Applicant authorizes RCG or its agent to obtain credit reports for the purpose of establishing, maintaining or enforcing a credit relationship. Upon approval of credit, Applicant agrees to pay RCG according to the terms granted herein and in separate terms and conditions provided by RCG, if any. The terms and conditions set forth in this Application may be modified only if in writing and mutually signed on behalf of both RCG and Applicant.

RCG may terminate trade credit to Applicant at any time, in its sole and complete discretion.

All invoices not paid within thirty (30) days from the date of invoice are subject to interest at the rate of one and one-half percent (1.5%) per month, retroactive to the date of invoice. In the event of any legal action or legal proceeding brought in connection with any amount due to RCG from Applicant, RCG shall be entitled to receive from the Applicant, in addition to any relief that may be granted, the reasonable attorneys' fees and costs (including, but not limited to, court costs, filing fees, and expert fees) incurred in the action or proceeding to collect any amount.

The person signing this Trade Credit Application on behalf of Applicant has read and fully understands the terms and conditions and is authorized to represent the Applicant in the matters described herein.

PERSONAL GUARANTY

For good and valuable consideration, receipt of which is acknowledged, this Personal Guaranty is made for the benefit of, and to obtain trade credit for Applicant from, Royal Construction Group, Inc., a Florida corporation ("RCG"). The undersigned ("Guarantor") hereby guarantees, on a joint and several basis along with any other guarantors of the obligations guaranteed herein, the performance of all obligations of Applicant to RCG, including, but not limited to, payment of all present and future indebtedness of Applicant to RCG, whether secured or unsecured and regardless of how the indebtedness is incurred and regardless of prior notice, demand or pursuit of remedies against Applicant.

This Personal Guaranty shall continue in effect until such time, if ever, Guarantor has delivered written notice of the termination of this Personal Guaranty; provided, however, that any such termination shall not alter any obligation of Guarantor arising hereunder prior to receipt of such written notice.

Guarantor hereby authorizes RCG or its agent to investigate Guarantor's credit and authorizes any bank, mortgage lender or landlord, credit reference or any other party to release information to RCG or its agent for such purpose, without liability to Guarantor for any such disclosure.

The obligations hereunder are independent of the obligations of Applicant to RCG, and a separate action or actions may be brought and prosecuted against Guarantor, irrespective of whether Applicant be joined in any such action or actions.

Guarantor waives all presentments, demands for performance, notices of nonperformance, protests, notices of protest, notices of dishonor, and notices of acceptance of this Personal Guaranty. RCG may enforce this Personal Guaranty prior to exercising, or in addition to exercising, any and all rights which RCG may have against Applicant under the terms of the Trade Credit Application or any other document or agreement entered into between Applicant and RCG.

This Personal Guaranty shall, in all respects, be construed, interpreted and enforced in accordance with and governed by the internal substantive laws of the State of Florida applicable to agreements executed and to be wholly performed within the State of Florida, without regard to choice of law rules thereof. Proper venue for any litigation concerning this Personal Guaranty shall be in the county designated by RCG and within the state of Florida. Each party hereto submits to the in personam jurisdiction of the State of Florida for purposes of any such litigation.

The parties hereto agree to negotiate in good faith to replace any illegal, invalid or unenforceable provision of this Personal Guaranty with a legal, valid and enforceable provision that, to the extent possible, will preserve the economic bargain of this Personal Guaranty.

No amendment, change or modification of this Personal Guaranty shall be valid unless in writing and signed by both RCG and the Guarantor. Time is of the essence of this Personal Guaranty and all of the terms, provisions, covenants and conditions hereof.

In the event of any legal action or legal proceeding brought in connection with any amount due to RCG from Guarantor, RCG shall be entitled to receive from the Guarantor, in addition to any relief that may be granted, the reasonable attorneys' fees and costs (including, but not limited to, court costs, filing fees, and expert fees) incurred in the action or proceeding to collect any amount.
